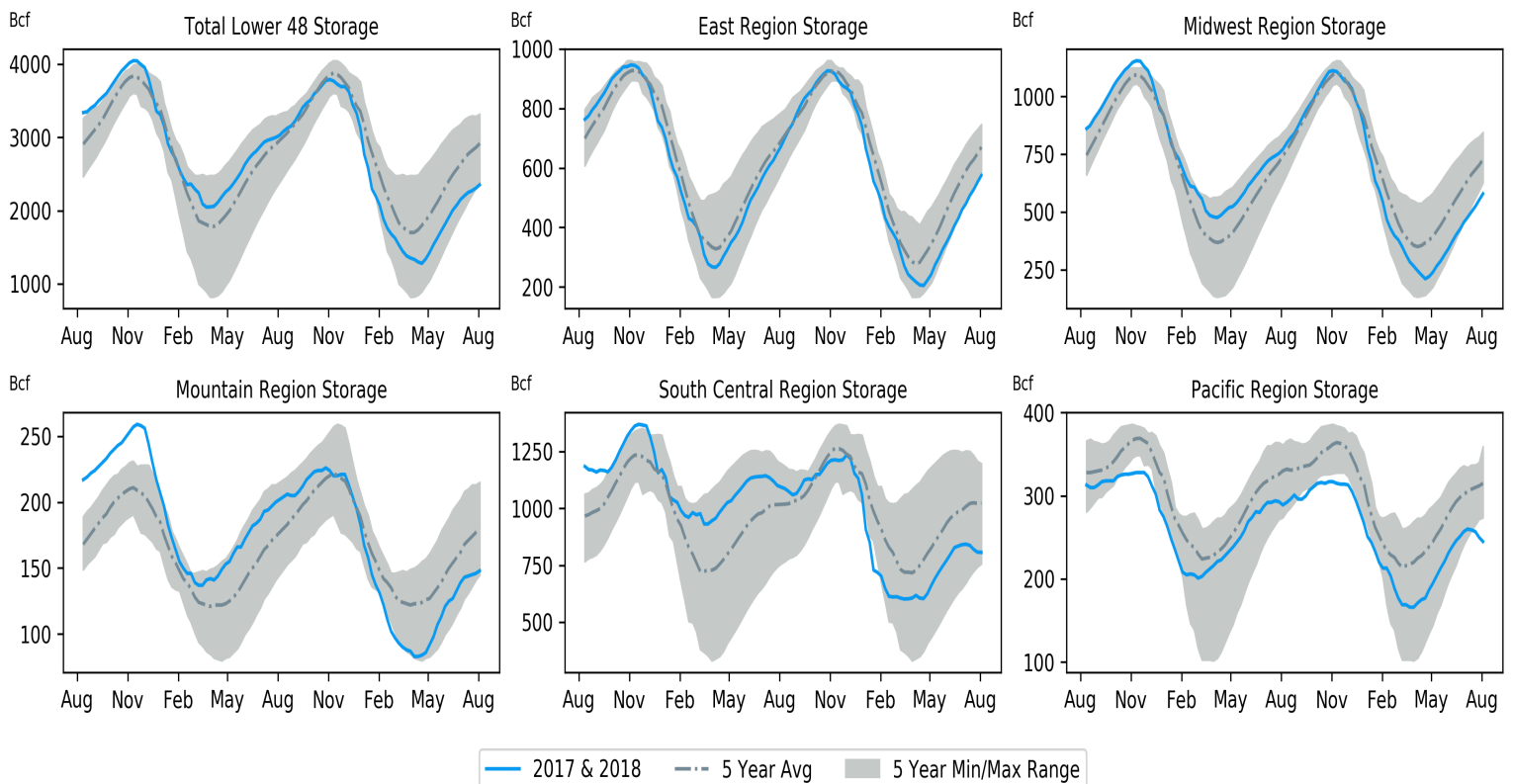
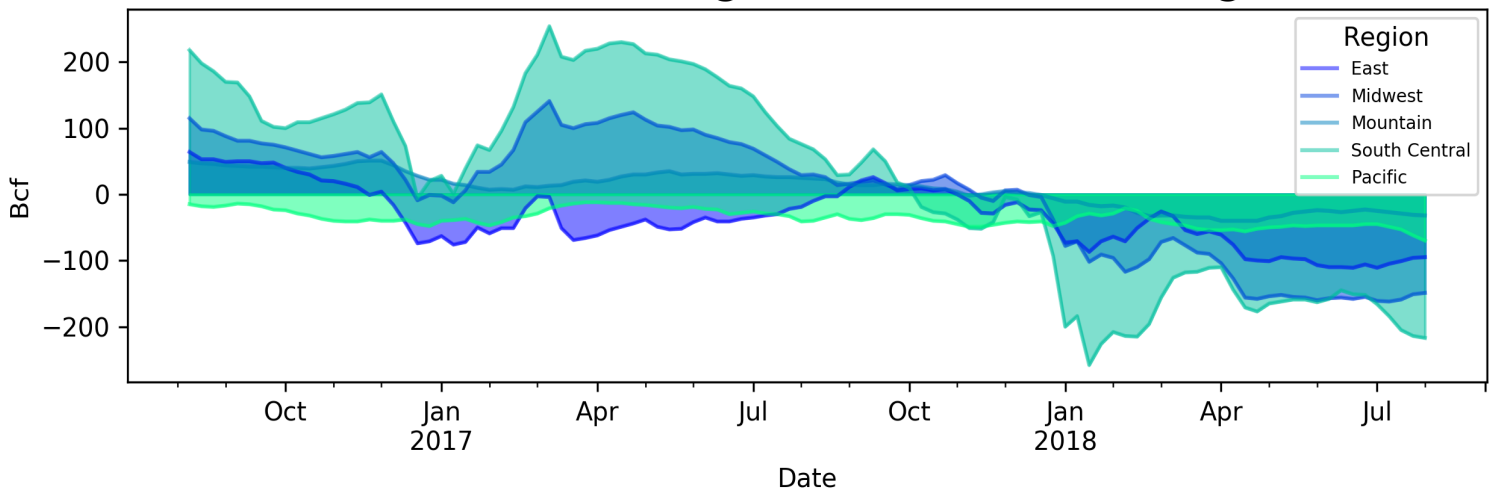

The EIA reported a 46 Bcf storage injection for the week ending Friday, August 03, 2018. Working gas in storage now sits at 2,354 Bcf which is down -22.2 % from one year ago and down -19.5 % from the five-year average. Stocks are now 671.0 Bcf lower than last year's level of 3,025 Bcf and 572.0 Bcf lower than the five-year average of 2,926 Bcf.

After the storage number was released front-month Henry Hub was down \$ -0.007/mmbtu to \$ 2.948/mmbtu and calendar 2018 Henry Hub was down \$ -0.003/mmbtu to \$ 2.784/mmbtu.
